### ABOUT THE TUITION OFFSET

### Who will receive the tuition offset

Starting in the 2021 Fall Term, a tuition offset will be applied to the accounts of applicable continuing graduate students. These offsets are available for up to one year for Master's and up to three years for PhD.

The offsets will be provided to continuing international graduate students only. However, the Master of Public Health (MPH) and Master of Sustainability (MSEM/MSs) programs will provide offsets for continuing domestic and international graduate students.

For students in master's programs that are designed to be completed in more than two years, please contact the graduate program administrator in your academic unit directly to discuss options.

An additional year of support for PhD students entering the second year of their program in 2021-2022 may be available as a bursary in their fifth year. Details on when to apply for this bursary in 2024-2025 will be provided in due course.

## When will the offset be applied?

The offset will be automatically applied to your student account sometime after the last day to make registration changes with 100% tuition credit, but before the tuition payment deadline. These dates are listed in the academic calendar and will be available on the class registration and withdrawal deadlines page in June 2021.
